## United Farmers of Alberta Co-operative Limited "Saddle Up to the CFR" Contest OFFICIAL CONTEST RULES AND REGULATIONS

("Official Rules")

Open to all residents of the Province Alberta, British Columbia and Saskatchewan

**1. NO PURCHASE NECESSARY:** The United Farmers of Alberta Co-operative Limited "Saddle Up to the CFR" Contest (the "Contest") is sponsored by United Farmers of Alberta Co-operative Limited ("UFA" or the "Sponsor"). The Contest starts at 12:00 AM Mountain Time ("MT") on June 30, 2023 and closes at 11:59 PM MT on September 4, 2023 (the "Contest Period").

2. ELIGIBILITY: To enter and be eligible to win, a person must: (1) be a legal resident of the Province of Alberta, British Columbia, or Saskatchewan; (2) have reached the age of majority at the time of entry in the Province or Territory in which they reside; (3) not be an employee of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies or the independent contest organization; (4) not be at any time of entry, an elected official, employee, petroleum agent or employee of a petroleum agent of/for the Sponsor, its subsidiaries, divisions, affiliates, associates, licensees, dealers, or service agencies; and (5) not be any member of any such person's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). ## 3. HOW TO ENTER THE CONTEST: There are two (2) ways to enter the Contest.

Online: During the Contest Period, enter online at <a href="www.ufa.com/rodeo.">www.ufa.com/rodeo.</a> Limited to one entry online for the Contest Period. Entries must be received by 11:59 PM MT on September 4, 2023 (the "Contest Closing Date").

**Without Purchase – Mail In:** During the Contest Period, on a plain piece of paper, hand print your full name, complete mailing address (including postal code), daytime telephone number (including area code) and/or a valid email address, and mail with sufficient postage to: "UFA Saddle Up for CFR" Contest c/o Marketing Communications, United Farmers of Alberta Cooperative Limited, Suite 700, 4838 Richard Road S.W., Calgary, Alberta, T3E 6L1. All entries must be received on or before the Contest Closing Date. There are no limits to the number of entries a person may submit by mail-in, but there is a limit of one (1) mail-in entry per mail piece.

**4. HOW**: There will be one (1) prize available to be won (the "**Prize**"), consisting of a VIP experience at the 2023 Canadian Finals Rodeo in Red Deer, Alberta, which includes a suite for Sunday, November 5, 2023, for six (6) people, a \$500 food and beverage credit, and a \$1,000

VISA Gift Card. The approximate retail value of the Prize package is Four Thousand (\$4,000.00) Dollars (CDN).

All other costs not specifically stated herein as being included with the Prize shall be the responsibility of any Prize recipients, including, but not limited to, travel. Changes may occur in some of the specifications, features, optional equipment and pricing of the Prizes. The manufacturer and Sponsor reserve the right to make such changes, if so required. Use and redemption of the Prize may be subject to separate terms and conditions of the issuer. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. Prizes will not be replaced if lost, stolen, or damaged by recipient. The Sponsor reserves the right, in the event that the Prize or any component of the Prize cannot be awarded as described for any reason, to substitute another Prize or component of a Prize of equal or greater value, without liability. PRIZE DRAW:** A random draw will be held for the Prize on September 18, 2023 at approximately 11:00 AM MT (the "**Draw Date**") in Calgary, Alberta from among all eligible entries received by the Contest Closing Date. Odds of being selected for the Prize depend on the total number of eligible entries received by the Contest Closing Date. The selected Prize recipient(s) will be contacted by mail, telephone or email within ten (10) business days of the Draw Date. If a selected Prize recipient (a) cannot be reached by mail, telephone or email within ten (10) business days of the Draw Date; (b) fails to correctly answer the skill testing question (see Rule 6); or (c) fails to return the properly executed Release Form, as provided by UFA, within the specified time (see Rule 6), then they will be disqualified and another Prize recipient will be randomly selected until such time as contact is made by mail, telephone or email with a selected Prize recipient or there are no more eligible entries, whichever comes first. The Sponsor will not be responsible for failed attempts to contact a selected Prize recipient.

The Sponsor and the independent contest organization will not be responsible for late, lost, illegible, incomplete or destroyed entries; all such entries are void.
