United Farmers of Alberta Co-operative Limited "Farmer's Day Get It Done & Get Away" Contest OFFICIAL CONTEST RULES AND REGULATIONS ("Official Rules")

Open to all residents of Canada (excluding residents of the Province of Québec)

1. NO PURCHASE NECESSARY: The United Farmers of Alberta Co-operative Limited "Farmer's Day Get It Done & Get Away" Contest (the "**Contest**") is sponsored by United Farmers of Alberta Co-operative Limited ("**UFA**" or the "**Sponsor**"). The Contest starts at 12:00 AM Mountain Time ("**MT**") on JUNE 9, 2022 and closes at 11:59 PM MT on JUNE 26, 2022 (the "**Contest Period**").

2. ELIGIBILITY: To enter and be eligible to win, a person must: (1) be a legal resident of Canada (excluding residents of the Province of Québec); (2) have reached the age of majority at the time of entry in the Province or Territory in which they reside; (3) be a member of UFA (4) not be an employee of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies or the independent contest organization; (5) not be at any time of entry, an elected official, employee, petroleum agent or employee of a petroleum agent of/for the Sponsor, its subsidiaries, divisions, affiliates, associates, licensees, dealers, or service agencies; and (6) not be any member of any such person's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). In these Official Rules, "**immediate family**" includes mother, father, brothers, sisters, sons, daughters, partner and/or spouse.

3. HOW TO ENTER THE CONTEST: There are three (3) ways to enter the Contest.

Online: During the Contest Period, enter online at www.coop.ufa.com/farmers-day. Limited to one entry online for the Contest Period. Entries must be received by 11:59 PM MT on JUNE 26, 2022 (the "**Contest Closing Date**").

Bonus Entry Online: During the Contest Period, make a purchase online at UFA.com. Must be registered in the Contest to qualify for bonus entry and complete transaction signed in as a customer with matching member number to enter. Entries must be received by the Contest Closing Date".

Without Purchase: During the Contest Period, on a plain piece of paper, hand print your full name, complete mailing address (including postal code), daytime telephone number (including area code), your UFA member number, your preferred participating UFA location, a valid email address, and mail with sufficient postage to: "**UFA Farmer's Day Get It Done & Get Away**" Contest c/o Marketing Communications, United Farmers of Alberta Co-operative Limited, Suite 700, 4838 Richard Road S.W., Calgary, Alberta, T3E 6L1. All entries must be received on or before the Contest Closing Date. There are no limits to the number of entries a person may submit, but **there is a limit of one (1) mail-in entry per mail piece.**

4. PRIZES: There will be five (5) prizes available to be won (each a “**Prize**”) as detailed below. All prizes are set out in Canadian dollars.

(a) **Grand Prize: \$10,000 Travel Voucher** – Consisting of one (1) WestJet Gift Card, valued at Ten Thousand (\$10,000) Dollars (CDN).

(b) **Second Prize: \$4,500 Travel Voucher** – Consisting of one (1) Direct Travel gift card valued at Forty-Five Hundred (\$4,500.00) Dollars (CDN).

(c) **Additional Prizes: 3 x \$1,000 Travel Vouchers** – Consisting of three (3) Direct Travel gift cards valued at One Thousand (\$1,000) Dollars (CDN) each.

All other costs not specifically stated herein as being included with the Prize shall be the responsibility of any Prize recipients. All federal, provincial and local taxes, if any, are the sole responsibility of each confirmed Prize recipient. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. Prizes will not be replaced if lost, stolen, or damaged. Use and redemption of the Prize may be subject to separate terms and conditions of the issuer. The Sponsor reserves the right, in the event that the Prize or any component of the Prize cannot be awarded as described for any reason, to substitute another Prize or component of a Prize of equal or greater value, without liability. In the event that a Prize recipient does not use or accept any portion of the Prize, there will be no extension, transfer, substitution or any kind of compensation provided.

5. PRIZE DRAW: A random draw will be held for each Prize on JULY 8, 2022 at approximately 10:00 AM MT (the “**Draw Date**”) in Calgary, Alberta, from among all eligible entries received by the Contest Closing Date. Odds of being selected depend on the total number of eligible entries received by the Contest Closing Date. Participants are only eligible to win one (1) Prize. The selected Prize recipients will be contacted by mail, telephone or email within ten (10) business days of the Draw Date. If the selected Prize recipient (a) cannot be reached by mail, telephone or email within ten (10) business days of the Draw Date; (b) fails to correctly answer the skill testing question (see Rule 6); or (c) fails to return the properly executed release form, as provided by UFA, within the specified time (see Rule 6), then they will be disqualified and another Prize recipient will be randomly selected until such time as contact is made by mail, telephone or email with a selected Prize recipient or there are no more eligible entries, whichever comes first. The Sponsor will not be responsible for failed attempts to contact a selected Prize recipient.

6. To be declared the winner, the selected Prize recipient must answer correctly, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question posed by mail, telephone or email. The selected Prize recipient will also be required to sign a declaration and release form, as supplied by UFA (the “**Release Form**”), confirming compliance with the Official Rules, acceptance of the Prize as awarded, without substitution, and releasing the Sponsor, its affiliated and related companies, advertising and promotional agencies, the independent contest organization, and their respective shareholders, directors, officers, employees, agents, representatives, successors and assigns from any liability in connection with the Prize or the Contest. The Release Form must be returned within the time period specified on the Release Form or the Prize will be forfeited.

The Sponsor will make the Prize available to the Prize recipient as either detailed by the Sponsor or at the UFA store closest to the Prize recipient’s place of residence within twenty one (21) days of being declared the Prize recipient. It is the responsibility of the Prize recipient to

pick up the Prize within fifteen (15) days of being notified of its availability, failing which the Prize is forfeited. The Prize will not be released unless the Prize recipient first shows proof of eligibility.

7. GENERAL: By entering the Contest, entrants agree to abide by the Official Rules and the decisions of the Sponsor, judges and independent contest organization with respect to all aspects of the Contest, which are final.

The Sponsor and the independent contest organization accept no responsibility for loss, damage or claims caused by or resulting from the Contest or the Prize associated with this Contest. By entering and accepting the Prize, the Prize recipient consents to the use of their name, address (location, hometown, city and province) and/or photograph, without further remuneration, in connection with any publicity carried out by or on behalf of the Sponsor with respect to this Contest and in advertisements for subsequent contests.

The Sponsor and the independent contest organization will not be responsible for late, lost, illegible, incomplete or destroyed entries; all such entries are void. The Sponsor and the independent contest organization do not assume any responsibility for lost or delayed mail-in entries, incorrect or inaccurate capture of entry information, technical malfunctions, human or technical error, printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer lines or networks, computer equipment, software or any combination thereof. Entry material/data that have been tampered with or altered are void. In the event it is determined that an entrant has entered in a fashion not sanctioned by the Official Rules, the entrant will be disqualified and all of the entries submitted by the entrant will be disqualified.

All entries become the permanent property of the Sponsor and none will be returned. All entries and related intellectual property rights, including but not limited to copyright, become the sole property of the Sponsor, without compensation to entrant. Upon entry each entrant irrevocably waives all moral rights protecting the entry. Entries, may, throughout the Contest and thereafter, be distributed, used, reproduced, exhibited, donated, sold and/or displayed by the Sponsor on their website or in a UFA location, which rights are granted by an entrant to the Sponsor upon entry, all without notice or compensation to entrant. No correspondence will be entered into except with the potential Prize recipient after the Contest Closing Date. This Contest is subject to all applicable Federal, Provincial and municipal laws.

Direct Travel is not a sponsor of nor otherwise affiliated or associated with this Contest, and is in no way responsible for the administration of the Contest.

WestJet Airlines Ltd. and its affiliates are not a sponsor of nor otherwise affiliated or associated the Contest, and is in no way responsible for the administration of the Contest.

The Sponsor and the independent contest organization shall not be held responsible for any problems, errors or negligence that may arise or occur in

connection with the Contest.
