

## **UFA CREDIT ON ACCOUNT MARKETING DISCLOSURE**

**INTEREST-FREE GRACE PERIOD** Interest will not be charged if the entire balance on the monthly statement is paid by the Payment Due Date (a minimum of 25 days after the date of the statement). You are entitled to prepay the full outstanding balance at any time without any prepayment charge or penalty.

**ANNUAL INTEREST RATE** Subject to any promotional offers, interest is charged at a rate of 18% per year, compounded monthly (equivalent to 19.56% per annum) and the interest rate may be changed by UFA at any time pursuant to the terms of the UFA Credit on Account Agreement.

**PAST DUE INTEREST** Subject to any promotional offers, if the entire balance is not paid in full by the Payment Due Date, then daily interest will be charged on the unpaid portion of the balance from the statement date to the date payment is received.

**MINIMUM PAYMENT** Subject to any promotional offers, payment of the entire balance by or on the Payment Due Date shown on the monthly statement is required.

**ANNUAL FEES** No annual fee is charged.

## **OTHER FEES**

**DISHONOURED PAYMENTS** - A handling charge of \$50 per item will be assessed.

**DEFAULT CHARGES** - If you are in default of the UFA Credit on Account Agreement you may be required to pay all reasonable costs incurred by UFA to collect or attempt to collect payment from you.

**PAYMENTS** For balance forward Accounts, payments are applied in the following order: first to all outstanding interest, second to any fees, and third to any unpaid principal amounts in order of payment due date. For open item Accounts, you are responsible for properly directing payments to be applied to specific purchases on your Account. If you fail to properly apply your payments to specific purchases, those purchases for which no payment has been applied will accrue interest as set out above.
