## United Farmers of Alberta Co-operative Limited "ATV Sprayer" Contest OFFICIAL CONTEST RULES AND REGULATIONS ("Official Rules")

Open to all residents of Canada (excluding residents of the Province of Québec)

**1. NO PURCHASE NECESSARY:** The United Farmers of Alberta Co-operative Limited "ATV Sprayer" Contest (the "**Contest**") is sponsored by United Farmers of Alberta Co-operative Limited ("**UFA**" or the "**Sponsor**"). The Contest starts at 12:01 AM Mountain Daylight Time ("**MDT**") on May 1, 2024 and closes at 11:59 PM MDT on August 31, 2024 (the "**Contest Period**").

**2. ELIGIBILITY:** To enter and be eligible to win, a person must: (1) be a legal resident of Canada (excluding residents of the Province of Québec); (2) have reached the age of majority at the time of entry in the Province or Territory in which they reside; (3) not be an employee of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies or the independent contest organization; (4) not be at any time of entry, an elected official, employee, petroleum agent or employee of a petroleum agent of/for the Sponsor, its subsidiaries, divisions, affiliates, associates, licensees, dealers, or service agencies; and (5) not be any member of any such person's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). With Purchase: During the Contest Period, any UFA customer who purchases at least one (1) jug of Corteva<sup>™</sup> Reclaim<sup>™</sup>II, Corteva Restore<sup>™</sup>II, Corteva Restore<sup>™</sup> NXT, or Corteva Grazon<sup>™</sup> XC restricted products, requiring Legal land description or pesticide permit ("Product") at a UFA Farm Store in Airdrie, Athabasca, Brooks, Camrose, Claresholm, Consort, Drayton Valley, Fort Saskatchewan, Grande Prairie, Grimshaw, High River, Kindersley, Leduc, Lethbridge, Mayerthorpe, Medicine Hat, Olds, Oyen, Provost, Red Deer, Spruce Grove, Stettler, St Paul, Strathmore, Taber, Two Hills, Vermillion, Westlock, will be automatically entered into the Contest.

Entries must be received by 11:59 PM MDT on August 31, 2024 (the "**Contest Closing Date**"). For every jug of Corteva<sup>™</sup> Reclaim<sup>™</sup>II, Corteva Restore<sup>™</sup>II, Corteva Restore<sup>™</sup> NXT, or Corteva Grazon<sup>™</sup> XC purchased during the Contest Period, from UFA a Farm Store in Airdrie, Athabasca, Brooks, Camrose, Claresholm, Consort, Drayton Valley, Fort Saskatchewan, Grande Prairie, Grimshaw, High River, Kindersley, Leduc, Lethbridge, Mayerthorpe, Medicine Hat, Olds, Oyen, Provost, Red Deer, Spruce Grove, Stettler, St Paul, Strathmore, Taber, Two Hills, Vermillion, Westlock, you will receive one (1) entry. Purchases can be cumulative over the Contest Period. Purchase of a Corteva Grazon<sup>™</sup> XC drum will be eligible for a maximum of eleven (11) entries.

**Without Purchase:** During the Contest Period, on a plain piece of paper, hand print your full name, complete mailing address (including postal code), daytime telephone number (including area code), a valid email address, your preferred participating UFA location and mail with sufficient postage to: "UFA **ATV Sprayer**" Contest c/o Marketing Communications, United Farmers of Alberta Co-operative Limited, Suite 700, 4838 Richard Road S.W., Calgary, Alberta, T3E 6L1. All entries must be received on or before the Contest Closing Date. There are no limits to the number of entries a person may submit by mail-in, but **there is a limit of one (1) mail-in entry per mail piece.** 

**4. PRIZES**: There will be one (1) prize available to be won (the "**Prize**"), consisting of a Braber Equipment Ltd. ATV Sprayer - 25 Gal, MODEL #90.812.250 SKU #1126908

The approximate retail value of the Prize package is \$449.99 (CDN).

All other costs not specifically stated herein as being included with the Prize shall be the responsibility of any Prize recipients. Changes may occur in some of the specifications, features, optional equipment and pricing of the Prizes. The manufacturer and Sponsor reserve the right to make such changes, if so required. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. The Sponsor reserves the right, in the event that the Prize or any component of the Prize cannot be awarded as described for any reason, to substitute another Prize or component of a Prize of equal or greater value, without liability. The selected Prize recipient will be contacted by mail, telephone or email within ten (10) business days of the Draw Date. If a selected Prize recipient (a) cannot be reached by mail, telephone or email within ten (10) business days of the Draw Date; (b) fails to correctly answer the skill testing question (see Rule 6); or (c) fails to return the properly executed Release Form, as provided by UFA, within the specified time (see Rule 6), then they will be disqualified and another Prize recipient will be randomly selected until such time as contact is made by mail, telephone or email with a selected Prize recipient or there are no more eligible entries, whichever comes first.
