Place ProStock Horse Mineral Supplement Tub in pasture areas where horses congregate. Adult horses should consume 0.5kg (1.1lb) per head daily. Monitor consumption and move tub father away from heavily used areas if consumption is too high and closer to water source if consumption is too low. Consumption will vary depending on whether horses are on pasture or in confined pens, and on age and size of horse. Place one tub for every 5 horses and place tubs far enough apart to prevent dominant horses from controlling more than one tub.
