#### **SECTION 4: FIRST AID MEASURES**

# **SECTION 5: FIRE FIGHTING MEASURES**

#### **SECTION 6: ACCIDENTAL RELEASE MEASURES**

#### **Toxicity of Other Components:**

The acute toxicity test results reported in Section 11, above, for the finished product take into account any acute hazards related to the "other components" in the formulation.

Propylene glycol: Reported to cause central nervous system depression (anesthesia, dizziness, confusion),

headache and nausea. Also, eye irritation may occur with lacrimation but no residual discomfort or injury. Prolonged contact to skin may cause mild to moderate irritation and possible allergic reactions. Chronic dietary exposure caused kidney and liver injury in experimental animals.
